Information and Communication Technology Agency of Sri Lanka (ICTA) is the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT.

With the increasing use of smart phones and mobile devises, mobile applications have been recognized as a key service base line in the e-service sector. By putting the understanding to practice, ICTA commenced developing mobile applications to deliver government services to citizens in the most effective and proficient manner. The mobile application for Train Schedules was the first application under this segment which was developed by ICTA, based on the existing e-service offered through Country Portal.

Usage of mobile applications to deliver government services has been identified as one of most effective as well as the efficient ways of accessing information along with the existing popularly of e-services. Hence, ICTA intends to initiate new projects that are to implement more mobile applications, which will enable more reliable accessibility to the government information and services.

ICTA now invites Expressions of Interest (EOIs) from eligible consulting firms that are willing to develop mobile applications for existing and new e-services.
