Information and Communication Technology Agency of Sri Lanka (ICTA), the apex Government Agency which has been mandated to take all necessary measures to implement the Government policy and the action plan in relation to ICT development in the county. ICTA is in the process of formulation and driving national level initiatives towards developing and empowering all sectors through the intervention of digital technologies. In this regard, ICT for Government sector has been considered as one of the key development area.

ICTA expects to provide training for government officers under web development and administration, content management systems and web management through this assignment. Consultant shall also provide accommodation, logistics and other arrangements mentioned in the "Terms of Reference". The duration of the assignment will be 12 weeks.
