Assignment Title: Hiring an Individual Consultant to study and technically facilitate revamping of eThaksalawa Platform- ICTA/GOSL/CON/IC/2016/55

The e-Thaksalawa is a project initiated by the ICT Branch of the Ministry of Education to establish the National e-learning portal of the General Education System that was launched in year 2013. The e-Thaksalawa provides resources aligning to all the subjects from Grade 1 to Grade 13 considering the GCE (A/L) streams.
