Terms of Reference Hire a software development consultant (firm) to develop the Child protection web platform

01 INTRODUCTION

The Information and Communication Technology Agency of Sri Lanka (ICTA) is the apex body in implementing the Government ICT policy and making recommendations for policies required for ICT based development in Sri Lanka aligning with the national development agenda.

As part of the above agenda, ICTA is in the process of formulation and driving national level initiatives towards developing and empowering all sectors through the intervention of digital technologies. In this regard, Information and Communication Technology (ICT) for fortification of children has been considered as one of the key development areas to be addressed. ICTA considers the need of creating a Sri Lanka where every child is confident, resilient and thriving.

02 BACKGROUND

The NCPA is interested in launching a web-platform that aims to provide and obtain information that can help parents, teachers, children, policy makers and other stakeholders make decisions that reduce vulnerability and increase resilience of children. The web platform is based on the philosophy that children who are confident and who feel good about themselves are less vulnerable to all forms of abuse. The NCPA believes that each family is unique and hopes that the information provided would be a guide that each family can adapt to suit their unique circumstances.

03 PROBLEM STATEMENT

There is a requirement to create a repository that holds information pertaining to child development and protection issues for parents, teachers, children, policy makers and other stakeholders, to make decisions that increases resilience and reduces vulnerability of children. Therefore, it articulates the necessity of establishing a digital platform specially designed to provide users with holistic information in one place.

04 OBJECTIVE(S)

To provide and obtain up to date, culturally relevant, information pertaining to child
development and protection issues, enabling parents, teachers, children, policy
makers and other stakeholders to make decisions that increases resilience and reduces
vulnerability of children and contributes to the overall protection of children via a
consolidated digital platform.



05 SCOPE

To develop a digital platform that provides holistic information on child development and protection issues. This platform will be governed by the National Child Protection Authority. As such all content on the site will be reviewed and approved by a Sri Lankan expert panel, appointed by the NCPA.

Target audience will be parents, teachers, children, policy makers and other stakeholders interested on child development and protection issues.

The aim of this assignment is to develop a web platform which facilitates the above mentioned objective in an efficient and an interactive manner. At the end of the assignment, a web platform would be developed consisting following elements.

- Information on up to-date, culturally relevant, information pertaining to child development and protection issues, including relationship building, good communication, physical, mental and sexual development of children, vetted by Sri Lankan experts for Sri Lankan public usage.
- Enhancing the public image of the NCPA
- An interactive content collection platform from various stakeholders and integrate it with a custom content authoring and publishing tool. Provide training on the custom authoring and publishing tool.
- Design the website in such a way that it follows a common style to provide maximum user friendliness and interactivity.
- Provide support on maintenance and updating the website.

06 SCOPE OF SERVICES

- 1. Study the services of NCPA to understand its functions pertaining to child development and protection issues and increases resilience and reduces vulnerability of children.
- 2. Brainstorm with the Content Management Team (CMT) members of NCPA to identify the requirements of the new web system and the content management platform, information clustering and information to be written and services to be provided by the web system to develop a new structure (to be verified through a cycle of prototypes) for the web system.
- 3. Design the website structure in all three languages (Sinhala, Tamil and English) and obtain the acceptance from CMT.
- 4. Develop the website in a manner that facilitates content management requirements through a custom content authoring and publishing tool and open standard Content Management System (CMS)/Software to add information and services incrementally as and when those become available across the website. And during the maintenance period should upgrade the CMS to latest stable version.
- 5. Arranging of the gathered contents in a logical and a realistic manner should be carried out by the developer in association with the CMT. Gathered contents will be signed off by the Content Manager who will be the head of CMT.



- 6. Direct, lead and manage the web development team that may comprise Graphic Designers, Photographers (if required), Web Developers, Database Developers and Integrators etc.
- 7. Develop website through incorporation of necessary and appropriate text, graphics, animations, sounds, photos, video clips, forms, databases, downloadable forms, plugging, quizzes etc. The scripting languages should be compatible with all browsers and the hosting server platform. NCPA will provide audio, photos and video clips.
- 8. Develop a total of 24 short video clips of 1 minutue (12 video clips in Sinhala and 12 with voice over in Tamil) and 24 animated cartoons of 1 minute (12 animated cartoons in Sinhala and 12 with voice over in Tamil) based on the requirements and to the specification of NCPA (Annex 01).
- 9. The overall site style and look and feel needs to go with the context of the NCPA preserving its image.
- 10. The web system initial layout could be as follows (Specification of the proposed web system). The consultancy firm is expected to provide suitable themes for the portal which will be reviewed by review committee.

11. Functional Requirements

- 1. Security and access levels;
 - a. Since children should not be allowed to view some content, developer should formulate security measures (Logins) to identify visitors based on age.
 - b. Security matrix to allocate staff user access levels according to role and office locations



- 2. Reporting facilities to produce a variety of ad hoc reports based on information of visitors.
- 3. Registration of NGOs working on child related issues.
- 4. Registration of all state actors working on child related issues.
- 5. Facilitate greater coordination with NCPA officers based in the districts and divisional levels
- 6. Provide a centralized repository for child development and protection related resources.
- 7. Mechanism to collect external resources i.e. articles/ research papers
- 8. Database to gather information on visitors

12. General features

- 1. Date of Last Update on each web page.
- 2. A link to the Sri Lanka Government web portal (www.gov.lk) and Local languages websites (Siyabas.lk, emadumolihal.lk, locallanguages.lk) etc.
- 3. Total number of pages will depend upon the requirements of the CMT of the NCPA. A web page shall contain at least 500 words except welcome page, news and event page, sitemap and home page.
- 4. The consultant shall be responsible for collecting, preparing, translating and typing of the content where domain expertise is not required. CMT of NCPA will collect, write and translate domain specific content. Translation and Typing can be from one of the language three languages (English, Sinhala and Tamil) to another.
- 13. Tools: Updating, Finding, Receiving, and Viewing Information
 - 1. Updating: Use a Customized Open source Content Management System (CMS) in order to provide content management support for all pages and parts of the website
 - 2. Ability to add users / user groups and define different privilege levels for them to add, update and delete content through content management tool. Administrator should



- have full rights to delegate the rights to users. Content management system should enable only authorized staff to add/edit/delete content
- 3. The content management system should be capable of activate/deactivate features/functions outlined in selected areas and articles of the website.
- 14. Finding: Ability to search information in all three languages including minimum of the following;
 - 1. Be used to find and view all documentation and information available in the website.
 - 2. Ability to sort results by various criteria.
 - 3. Link the results from searches of documentation to relevant audio and video records

 - 5. Web pages should be accessible via predefined URL according to NCPA Standards
 - 6. Ability to Navigate content in smooth user-friendly and sensible manner
 - 7. The Latest version of CMS which should support LAMP environment.
 - 8. Website developer should adhere to the highest standards conforming to Word Wide Web (W3C) standards and the latest version of ICTA web standards for the government organizations. Web standards for Government Web Development are also available at

 - 9. Website database structure (Schema definition) and Entity Relationship Diagram (ERD) is mandatory.
- 18. Testing and Quality Assurance



- 1. Quality Assurance should be guaranteed for the whole web system in all aspects.
- 2. Quality Assurance approach should be described in detail in the Methodology.
- 3. The web developer should implements all necessary security measures and adhere to the security measures proposed by Sri Lanka Computer Emergency Response Team (SLCERT) for ensuring the security of the websites where the Website should be immune to exploitations such as, SQL Injection; Cross-site scripting (XSS); Session/URL poisoning etc.

19. Monitoring and Auditing

- 1. The website should include statistic generating tool(s) which can generate statistics: Hit counter; Number of page loads; Number of hits received; Pages accessed by the user; Visitor's location based information etc.
- 2. The website should include tool(s) (nonproprietary) that can generate statistics about users who publish, update, delete any content of the website

20. Archiving - Ability to archive content / documents and also to search archived documents

1. Extensions - Consultant should provide provision to extend the website for Services facilities that shall arise in future.

21. Hosting

- 1. Cost of website hosting space during the development of the website should be borne by the consultant and that server should be located in Sri Lanka.

 - 4. Upgrade Open Source Content Management System version and sort all issue that may arise due to upgrading such as content alignment, security etc during the maintenance period.



5. Attend to all types of Corrective maintenances (Bug fixing and installing of security patches). If user discovers any error/failure in the website, web consultant should respond and rectify immediately. Meantime to Response (MTR) should not exceed one hour and Mean Time to Resolution should not exceed 24 hours from the time of being informed. Notification of errors/failures should be possible through email, telephone, and fax or in letter format.

24. Ownership of the web system

- 1. The website developer should provide soft copies of all source codes, databases, Content Management Tool, graphics (source file) and hard copies of design documentations and other related documents used in the website.
- 2. Intellectual property rights relating to the graphics, photos (captured by the photographers), text, artwork, design, sound recordings, software, database, and any other components developed for this project by the consultant shall be the property of NCPA and shall have the right to transfer such rights to the community it prefers.
- 3. If any proprietary software components belonging to the consultant shall be licensed to NCPA for perpetual use. The consultant shall require making appropriate arrangements to make available the source code of the said proprietary software to the client in the event of either bankruptcy or winding of merger of the consultant company.
- 4. Content Management Tool's passwords (including super user password) and File Transferring Protocol (FTP) password should be handed over to NCPA after signing off the website. The passwords can be obtained from NCPA during the maintenance period.



- 5. Vendor should impose the copyright and disclaimer notice as specified by the Purchaser.
- 6. All confidential information exchanged during the assignment should not be disclosed by the consultant to a third party.
