**Assignment Title: Legal background study for assessing legal amendments and new regulatory requirements for National Spatial Data Infrastructure Project**

Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the purview of the Ministry of Telecommunication and Digital Infrastructure (MTDI) is in the process implementing National Spatial Data Infrastructure (NSDI) project in order to improve optimum use of spatial data across the government and making effective evidence based decisions. This project has been identified as one of the key initiatives identified under *the National Digital Policy of the Government of Sri Lanka; "Digitalization of the Economy"*.

ICTA intends to obtain the service of an individual consultant to carry out a comprehensive legal background study to define the legal specifications on NSDI to identify the relevant legal entities from the existing acts, ordinances, policies, legislations and draft regulations regarding NSDI and to propose legislation for the NSDI, if needed.
