Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the preview of Ministry of Telecommunication and Digital Infrastructure is the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT.

In concurrent world, many economies have brought up digital commerce to facilitate governments, businesses and citizens to be able to perform digital commerce and financial transactions with efficiency, ease and low cost. ICTA in collaboration with the Ministry of Finance, has taken the initiative of bringing up digital commerce with ease in Sri Lanka by introducing "The Online Payment Service".
