Information and Communication Technology Agency of Sri Lanka (ICTA) is in the process of implementing a single window Land Bank, in collaboration with the Ministry of Lands, with the aim of developing single window for land surveying, title clearance, land acquisition, land use planning, valuation and registration and all land related matters. Ministry of Lands has identified the Land Bank program as one of the priority projects identified as a part of the Digital Government initiative of ICTA.
