Assignment Title: Transferring Government websites from GIDC to new PAAS environment (Lots I & II)

Information and Communication Technology Agency of Sri Lanka (ICTA) is the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT.

ICT Agency of Sri Lanka initiated the government web development project in year 2005 to increase the government web presence and up to now, we have successfully launched more than 500 trilingual websites.

Currently, the web hosting facility is located in Government Information Data Center (GIDC) which is managed by Lanka Government Information Infrastructure (LGII). However, ICTA intends to host all the website in Docker container environment which are operated in isolated location.

ICTA now invites Expressions of Interest (EOIs) from eligible consulting firms that are willing to undertake these two assignments described below:

Eligible Service providers (Firms) shall submit Expressions of Interest only for **ONE** of the assignments based on their interest and qualification. One consultant (Firm) shall only be short listed for only one of the assignments.

EOI must include requested information as specified in the "EOI Information Form" along with documentary evidence in support of core business and years in business, Financial, Business and Administrative strength/standing, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of key staff of the organization and other relevant information.

Consulting firms will be selected in accordance with the procedures set out in the Government Guidelines: Selection & Employment of Consultants; following Least Cost
