Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the purview of Ministry of Telecommunication and Digital Infrastructure, is the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT.

In order to achieve the vision of digitization of the economy initiative, ICTA is implementing over 80 projects in 2017 aiming to develop national digital infrastructure, provide effective digital government services, country wide connectivity and affordable digital access and empower citizens to be able to use the benefit of digital technologies. To measure the achievement of results of these initiatives, ICTA plans on implementing a comprehensive monitoring and evaluation (M&E) system across all the projects and programmes.

Since collection and analysis of monitoring data through a manual system has become extremely complex and a cumbersome process, efficiency, effectiveness and data quality can be significantly improved by automating the data collection, analysis and reporting procedures. In order to meet the stakeholder reporting requirements efficiently, there is a need to implement a solution to see the project progress and generate timely reports based on the stakeholder requirements.
