REQUEST FOR EXPRESSIONS OF INTEREST

Information and Communication Technology Agency of Sri Lanka (ICTA) has launched Lanka Interoperability Framework (LIFe) to acts as a guide for government organizations in developing ICT systems that facilitate exchange of data and information in a consistent and standardized manner. Implementing LIFe standards would not only avoid errors in data in information systems but also provides significant cost savings for government organizations by reducing duplication and increasing collaboration. To date LIFe standards have been developed for Personal, Vehicular, Development projects coordination, and Land domains. ICTA now intends to develop interoperability standards in the Judicial Sector with the involvement of all the ministries, departments and agencies in the Judicial sector.

To implement LIFe standards in the Judicial sector, ICTA now invites Expressions of Interest (EOIs) from intended eligible and experienced firms to indicate their interest in providing the services. EOI must include requested information as specified in the "EOI Information Form" along with documentary evidence in support of core business and years in business, Financial, Business and Administrative strength/standing, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of key staff of the organization and other relevant information.

Firm will be selected in accordance with the procedures set out in the Government Guidelines: Selection & Employment of Consultants following selection on consultant qualification (CQS) method.
