**Assignment Name: Conducting Security Audits for Government Websites**

**REQUEST FOR EXPRESSIONS OF INTEREST**

Information and Communication Technology Agency of Sri Lanka (ICTA) with the collaboration of the Sri Lanka Computer Emergency Response Team Co-ordination Centre (Sri Lanka CERT|CC) and Ministry of Telecommunication and Digital Infrastructure, aim to implement a project to conduct vulnerability assessments and penetration tests for all websites of government organizations. The purpose of this project is to identify possible security threats and provide recommendations to individual government organizations to address those possible security vulnerabilities. Initially, ICTA intends to conduct audits for approximately 120 web sites of government institutions which include ministries and departments.

Website assessments are carried out in three phases. In the first phase, an initial assessment of the government website will be carried out to identify the possible security issues and to advise the respective government organizations on fixing the identified security issues (if any). At the second phase, based on the identified security issues, government organizations will fix those security issues. At the third phase follow-up audits will be conducted to examine whether the identified security issues have been sufficiently addressed by the relevant government organizations.

To conduct security audits for government organizations, ICTA now invites Expressions of Interest (EOIs) from interested eligible and experienced firms that are willing to undertake this assignment to indicate their interest. If a foreign firm is interested in the assignment they must have an association in the form of joint venture with a local firm. Any form of subcontracting is not allowed. In order to expedite the process, firms are expected to have two teams for parallel implementation.

EOI must include requested information as specified in the "EOI Information Form" along with documentary evidence in support of core business and years in business, Financial, Business and Administrative strength/standing, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of key staff of the organization and other relevant information.

Interested parties may download these documents from the website <https://www.icta.lk/procurement/> Firm will be selected in accordance with the procedures set out in the Government Guidelines: Selection & Employment of Consultants following Least Cost Selection (LCS) Selection method. All interested parties are informed that all documentations shall be in English Language.
