Information and Communication Technology Agency of Sri Lanka (ICTA) is the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT and its functions under direct purview of the Ministry of Telecommunication and Digital Infrastructure. ICTA has embarked on a series of ICT Development initiatives for the implementation of Digital Infrastructure solutions and other projects across multiple sectors.

In the domain of Education ICTA has taken several initiatives to develop the ICT skills in Students. One such initiative is the "All Children Coding Programme" which will develop the students' logical and creative thinking, problem solving skills, programming and entrepreneurship. A coding curriculum is being developed to deliver the content to students. ICTA will conduct a TOT Training for teachers on the developed curriculum. A formal, structural, systems will be established to teach coding from the earliest childhood.

ICTA requires the services of a consultancy organization/firm to provide a comprehensive TOT training to 200 government teachers the developed coding Teacher Instruction Manual (TIM).

ICTA now invites Expressions of Interest (EOIs) from eligible consultants (firms) that are willing to undertake the above assignment.
