The Information and Communication Technology Agency of Sri Lanka (ICTA), functions under the preview of the Ministry of Telecommunication and Digital Infrastructure (MTDI), is the apex ICT institution of the Government of Sri Lanka. ICTA has planned to introduce Digital Libraries Project in collaboration with the National Library and Documentation Services Board. It is proposed to establish 26 Digital Libraries, one in each District and at the National library to provide convenient and affordable access to electronic information/eBooks and educational materials, whilst encouraging the usage of Digital Libraries. The required digital infrastructure, equipment and the capacity development will be provided by the ICTA to support the initiative.

ICTA wishes to obtain the services of an experienced Individual Consultant in the field of library and information management to introduce the Integrated Library Management System (ILMS) and Model Digital Library concept intended to be implemented under the Digital Library Project. ICTA hereby invites Expressions of Interest from qualified professionals to carry out the assignment.

Exposure to international library management systems
