The Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the preview of the Ministry of Telecommunication and Digital Infrastructure (MTDI), is the apex ICT institution of the Government of Sri Lanka. ICTA has planned to initiate Digital Libraries Project in collaboration with the National Library and Documentation Services Board. The purpose of establishing Digital Libraries is to provide convenient and affordable access to electronic information/eBooks and educational materials, whilst encouraging the usage of Digital Libraries. It has been planned to establish 26 Digital Libraries, each in every District and one at the National Library in Colombo. The required digital infrastructure, equipment and the capacity development will be provided by the ICTA to support the initiative.

ICTA intends to obtain the service of an Individual Consultant to conduct a Baseline Survey for the Digital Libraries Project as a part of the project initiation process.

Duration of the assignment shall be 16 weeks commencing from August, 2017
