**Assignment Title: Designing, Developing, Deploying and Maintenance of the eLand Registry Document Management System - Contract No: ICTA/GOSL/CON/QCBS/2017/21**

Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the purview of Ministry of Telecommunication and Digital Infrastructure, in collaboration with the Registrar General's Department is in the process of implementing a Document Management System (DMS) for eLand Registry Project.
