## Request for Expressions of Interest Conducting National IT-BPM Workforce Survey 2018 Contract No: ICTA/GOSL/CON/QCBS/2018/50

Information and Communication Technology Agency of Sri Lanka (ICTA) that functions under the purview of the Ministry of Telecommunication and Digital Infrastructure and Foreign Employment is the the apex government agency for Information and Communication Technology (ICT) in Sri Lanka which has been mandated to take all necessary measures to implement the Government's Policy and Action Plan in relation to ICT. ICTA has embarked on a series of ICT Development initiatives for the implementation of Digital Infrastructure solutions and other projects across multiple sectors.

With these planned initiatives, ICTA intends to carry out National ICT Workforce Survey. The aim of the workforce survey is to gain a clear understanding of the extent and the composition of IT and Business Process Management (BPM) workforce in Sri Lanka and to weigh that against the extent of the supply of skilled personnel.

The achievement of this aim will enable;

- The IT and BPM suppliers, user organizations and the public sector gain a realistic picture of the overall demand, supply and skill gap of IT and BPM Human Resources.
- Universities and other IT and BPM training institutions to improve their offerings.
- Students to select their career paths which will lead to future employment opportunities in the IT and BPM industry.
- Potential investors to have vital information about the IT and BPM workforce that will help them make their investment decisions.
- Policy makers to use the data for Human Resource planning and development.

The IT-BPM Workforce survey will also replicate and build on the four previous survey rollouts already completed in 2004, 2006, 2010 and 2013 which would enable a longitudinal study of the nature of the IT-BPM workforce. Where important modifications deemed necessary might be made, but always ensuring that longitudinal studies can still be carried out.

ICTA now invites Expressions of Interest (EOIs) from eligible consultants (firms) that are willing to undertake this assignment. EOI must include requested information as specified in the "EOI Information Form" along with documentary evidence in support of core business and years in business, Financial, Business and Administrative strength/standing, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of key staff of the organization and other relevant information.
