2.	Item No. 2: "Audio Inputs" Page No. 53 Q: Please clarify the number of Microphone inputs?

	C: This shall read as "Support three Microphone Inputs" not two.
3.	<u>Item No. 1: "Number of concurrent Meetings" Page No. 36</u> Q: Is it possible to increase the number of Concurrent meeting to 40? C: No.
4.	<u>Item No. 1: "Video Standards" Page No. 37</u> Q: Is it possible to remove WebM, VP8? C: Yes. It shall read as HTML5/WebRTC, SIP, TIP (Telepresence Interoperability Protocol), H.323, Microsoft RTV
5.	<u>Item No. 1: "Audio Standards" Page No. 37</u> Q: Is it possible to remove Speex and Opus? C: No. This is an optional feature.
6.	<u>Item No. 1: "Management Tools" Page No. 38</u> Q: Is it possible to change the packet loss up to 5%? C: No.
7.	<u>Item No. 1: "MCU Administrator Privileges" Page No. 41</u> Q: Is it possible to remove limits such as: * Managing Maximum Bandwidth and * Maximum Number of Participants who can join the conferences of the users who belong to the group under User Group Management? C: No.
8.	<u>Item No. 1.1: "Video Conferencing Desktop Application (Web based and Client) - Instant Messaging" Page No. 45</u> Q: Is it possible to remove critical ("C") for Support Private Chat with Conference Participants under the Instant Messaging? C: Yes. Priority can be changed from critical ("C") to optional.
9.	<u>Item No. 1.1: "Video Conferencing Desktop Application (Web based and Client)" - Supported Web Browsers. Page No. 47</u> Q: Is it possible to add IE to the Supported Web Browsers? C: Yes. Supported Web Browsers: shall read as Latest Version of Chrome, Firefox, Safari, Edge/IE, etc.
10.	<u>Item No. 1.2: "Video Conferencing Mobile Application for Tablets & Smartphones" - Supported Video Standards. Page No. 47</u> Q: Is it possible to add 264 (HP) / 265 under the Supported Video Standards? C: Yes.
11.	<u>Item No. 1.2: "Video Conferencing Mobile Application for Tablets & Smartphones - Video Layout" Page No. 48</u> Q: It was requested to add "Ability to see self and to see far site video under the Video Layout? C: Yes. This shall read as Picture in Picture (PIP)/Ability to see self and to see far site video.
12.	<u>Item No. 1.2: "Video Conferencing Mobile Application for Tablets & Smartphones" - User Interface. Page No. 48</u> Q: It was requested to remove "C" for Presence Status of Contacts (Available, Logged off, Busy) under the User Interface? C: Priority changed from critical ("C") to optional.

13.	<p><u>Item No. 1.2: “Video Conferencing Mobile Application for Tablets & Smartphones” - Supported Operating Systems. Page No. 49</u></p> <p>Q: It was requested to remove “C” for Windows Mobile (latest version) under the Supported Operating Systems?</p> <p>C: Priority changed from critical (“C”) to optional.</p>
14.	<p><u>Item No .2: “Video Conference Endpoint” – Video Inputs. Page No. 51</u></p> <p>Q: Is it possible to amend Support minimum <u>two</u> HDMI input to <u>one</u> HDMI port under the Video Inputs?</p> <p>C: No. However input could be changed to “two HDMI ports”.</p>
15.	<p><u>Item No .2: “Video Conference Endpoint” – Solution Package Contents. - Page No. 50</u></p> <p>Q: Could the bidder suggest remote controller device for 10-inch Touch Pad for controlling the endpoint under the Solution package Contents?</p> <p>C: No.</p>
16.	<p><u>Item No .2: “Video Conference Endpoint” – Camera Features. Page No. 55</u></p> <p>Q: Is it possible to amend 5x Digital zoom to Optical zoom in the Camera Features?</p> <p>C: Yes. It shall read as 5x Digital/Optical zoom.</p>
17.	<p><u>Item No .4: “Display Panel Stand for Video Conference Endpoint” - Supported Weight. Page No. 60</u></p> <p>Q: It was requested to reduce the weight for Display Panel stand?</p> <p>C: Yes. Bidder can specify the weight. Priority level has been changed from critical (“C”) to optional.</p>
18.	<p><u>Section III. Evaluation and Qualification Criteria (b) Experience and Technical Capability Page No. 22</u></p> <p>Q: It was requested to remove “experience in similar local projects/orders” as a requirement for qualification criteria.</p> <p>C: Yes. This has been changed. (Refer Annex 1)</p>
19.	<p><u>Annex 1: Page No. 96</u></p> <p>Q: What would be the Seating Capacity details for the two locations?</p> <p>C: Seating capacity would be 20 for each location.</p>
