Assignment Title: Designing, developing, implementing and maintenance of eRevenue License 2.0 (eRL 2.0).

Information and Communication Technology Agency of Sri Lanka (ICTA) functions under the purview of Ministry of Digital Infrastructure and Information Technology of the government of Sri Lanka implemented e-Revenue License (eRL) project in December, 2009 initially in the Western Province. This was the first connected and centralized web enabled transactional eService offered to the citizens by government. The e-RL solution consists of a centralized web enabled system used by Divisional Secretariats (DS) to issue Revenue License and an online service (eService) which facilitates citizens to renew their licenses online.

Several stakeholders such as the Provincial Departments of Motor Traffic (PDMT), Department of Motor Traffic (DMT), insurance companies, emission testing companies, banks and financial organizations etc provide connected services essential to the system. Currently, this solution has been successfully rolled out in all Divisional Secretariats throughout the country.

The eRL solution holds revenue license records for all the vehicles running in the country and the system is now running on its fullest capacity. The performance of the solution has now become very slow. The stakeholder organizations have requested to accommodate number of enhancements to the solution in order to provide more efficient and effective service to vehicle owners.

In order to overcome issues of the existing solution and having an advanced solution in place for smooth functioning of services offered through the existing features and providing a better service through new features identified, it has been stressed the necessity of re-developing eRL solution.

Accordingly, ICTA intends to engage a software developing firm to design, develop, implement eRL 2.0 with new features using the latest technology and to provide support and maintenance for three (03) years for the implemented solution.

ICTA now invites eligible software developing firms that are willing to undertake this assignment to express their interest for the Expressions of Interest (EoIs). Responses must include the requested information as specified in the "EoI Information Form" along with documentary evidence in support of core business and years in business, Financial, Business and Administrative strength/standing, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of key staff of the organization and other relevant information.

Software developing firm will be selected in accordance with the procedures set out in the Government Guidelines: Selection and Employment of Consultants following Quality and Cost Base Selection (QCBS) method. All interested parties are informed that all documentations shall be in English Language.

Responses to the Request for Expressions of Interest by Joint Ventures, consortia, sub consultancy or any other form of associations are not allowed under this assignment and therefore shall not be considered for evaluation and short listing.
