The SMART Social Circle (SSC) program initiated by the Information and Communication Technology Agency (ICTA) has opened new opportunities for communities living in the urban, suburban and rural areas via Digital technology, enabling them to connect with government and non-government organizations. The main objective of this Smart Social Circle is to improve the wellbeing and living standards by social economic growth of communities who are becoming digitally literate. Moreover, small to medium level business and enterprises have directly benefited from the initiative and multiple level relationships have been established across the private and public sector.

This was initiated in 2016 and ICTA is continuing SMART Social Circle initiative for the year 2019. There are three mainly focused areas, namely,

- 1. The **SSC rollout** establish 30 SSC's in relation to group of entrepreneurs produce same products in particular areas of the country.
- 2. The **continuation of the project** will ensure the sustainability of the already established SSC's and facilitate to effective functioning of SSC with adequate support from ICTA.
- 3. Train 10000 entrepreneurs efficiently and effectively use of social media with the collaboration of Facebook
