1.	Section III. Evaluation and Qualification Criteria, "(b) Experience and Technical Capability" Q: Documentary evidence for experience can be submitted foreign and local projects. C: Yes.
2.	Section V. Schedule of Requirements, "1.2 List of related services." Q: Delivery of the subscription activation period can be extended for 3 weeks? C: No.
3.	Section V. Schedule of Requirements, "Delivery and Installation" Q: When to start the implementation? C: Should start after the Letter of Award is received.
4.	Section V. Schedule of Requirements, "1.3 Training" Q: Should training provide only the Virtual Training or with Red hat certification? C: Only the Virtual Training.
5.	Section VII. Contract Data, "C 27.7 – Service Level Agreement" Q: Maintenance and support services should offer by OEM or Local vendor support? C: Support Services from Original Equipment Manufacturer (OEM).
6.	Section VII. Contract Data, "CC 15.1 – Conditions of payment" Q: Please Clarify: Payment shall be made in Sri Lanka Rupees within thirty (30) days of presentation of claim supported by a certificate from the Purchaser declaring that the usability of bandwidth have been made available and that all other contracted Services have been performed. C: Should be changed as: Payment shall be made in Sri Lanka Rupees within thirty (30) days from the date of submission of Invoice, UAT acceptance, and other documents requested in the IFB.
