The Information and Communication Technology Agency of Sri Lanka (ICTA) has been mandated to implement solutions that will enable the Government of Sri Lanka to achieve its aim of providing all of its services through ICT to citizens.

The Ministry of Health (MoH) intends to formulate a digital health architecture blueprint, an interoperability operational plan, and a capacity development & technical assistance plan. The objective is to integrate a system of health care for patients, improve the health of the population, and improve control over health care costs by promoting health maintenance, prevention, and care coordination. In collaboration with the Global Fund, MoH has initiated the 'Health Information and Quality Improvement Project' and intends to develop resilient and sustainable systems for the health domain.

ICTA, as the apex ICT institution of the government, intends to facilitate MoH for the above project and its implementation activities while continuing to provide technical and other consultancy services related to ongoing initiatives. ICTA is inviting EOIs from qualified Software Engineer-PHP to engage in the Health Information and Quality Improvement Project.

Working experiences in Electronic Medical Records (EMR) solutions, knowledge on HL7 standards will be an added advantage

Understanding of software development within the Agile process.
