The Information and Communication Technology Agency of Sri Lanka (ICTA) has been mandated to implement solutions that will enable the Government of Sri Lanka to achieve its aim of providing all of its services through ICT to citizens.

The Ministry of Health (MoH) intends to formulate a digital health architecture blueprint, an interoperability operational plan, and a capacity development & technical assistance plan. The objective is to integrate a system of health care for patients, improve the health of the population, and improve control over health care costs by promoting health maintenance, prevention, and care coordination. In collaboration with the Global Fund, MoH has initiated the 'Health Information and Quality Improvement Project' and intends to develop resilient and sustainable systems for the health domain.

ICTA, as the apex ICT institution of the government, intends to facilitate MoH for the above project and its implementation activities while continuing to provide technical and other consultancy services related to ongoing initiatives. ICTA is inviting EOIs from qualified Executive - Central Province to engage in the Health Information and Quality Improvement Project.

The consultant would be based at the Office of the Provincial Director of Health Services - Central province. A consultant is responsible for the Hospital Health Information System (HHIMS) implementation, expansion and providing support services to the selected HHIMS-implemented hospitals in Central Province.

Duration of the assignment: 12 Months (Full-time)

Bachelor's Degree in Computer Science, Information Technology, Management Information Systems or equivalent qualifications related to the field from a recognized university/institution

Minimum of two years' relevant professional experience.
