1. SECTION II: BID DATA SHEET: The below ITB clauses are amended as follows.

ITB 22.1 Period of Validity of Bids	Bid validity period shall be 147 Days from the Deadline for Submission of Bids inclusive of the deadline date for submission of Bids as specified below in reference to ITB Clause 26. Accordingly, the Bids shall be valid until December 26, 2023.
ITB 23.2 Bid Security	Bid Security must be an unconditional bank guarantee, submitted using only the prescribed form included in this Bidding Document. Bid Security should be from a Commercial Bank and valid for One Hundred and Seventy-Five days (175) from the date of deadline of submission of bids inclusive of the deadline date for submission of bids. (Valid until January 23, 2024) Bid Security shall be valid for 28 days beyond the original validity period of the bid(Valid until January 23, 2024). If the Bid Security is to be issued by a bank outside Sri Lanka, it shall be from a bank that has a correspondent bank in Sri Lanka. Banks in Sri Lanka issuing the bank guarantee shall be a licensed commercial bank under the Banking Act No. 30 of 1988 and supervised by the Central Bank of Sri Lanka. The Bid security shall be enforceable in Sri Lanka.
